Mr. Stefan Recker, born on June 2, 1963, was employed from November 14th, 2008 until October 31st, 2012 with Welthungerhilfe in various positions and regions. This in fact was his second employment by Welthungerhilfe, as he had been working already between January 8th, 2001 and February 29th, 2004 with us. This period is being covered by a separate letter of reference, to which we refer here as well.
